



2017 PRINCETON SHOW JUMPING VENDOR CONTRACT

TERMS AND CONDITIONS

Our policy is to accept Vendors as space permits, while limiting the number of Vendors with similar wares. Vendors of souvenir items displaying the PRINCETON SHOW JUMPING logo or verbiage, official or unofficial, shall require prior written approval by PRINCETON SHOW JUMPING. PRINCETON SHOW JUMPING reserves the right to reject any application for any reason whatsoever. No specific Vendor location or "space" can be guaranteed.

Please be advised that your application does not constitute a contract with PRINCETON SHOW JUMPING until each of the following requirements are satisfied: (1) PRINCETON SHOW JUMPING notifies you in writing that you have been identified as a potential Vendor, and (2) you satisfactorily provide copies of the requisite insurance certificates and business licenses set forth below. (3) Payment is received for the vendor space. A \$300.00 fee if renting a tent from Princeton Show Jumping is also due prior to the show.

In the event that you are identified as a potential Vendor, you will be required to provide PRINCETON SHOW JUMPING each of the following:

- (1) A certificate of insurance evidencing a policy of One Million Dollars (\$1,000,000.00) per occurrence, Two Million Dollars (\$2,000,000) aggregate in Combined Single Limit Bodily Injury and Property Damage insurance, including products/completed operations naming HUNTER FARMS and PRINCETON SHOW JUMPING, doing business in New Jersey as PRINCETON SHOW JUMPING as specifically designated additional insured. A certificate of insurance for Workers' Compensation and Employment Liability in the amount of no less than One Hundred Thousand Dollars (\$100,000.00) per occurrence.
- (2) A photocopy of your New Jersey State Certificate of Authority to Collect Sales Tax, which serves as evidence that you have met the sales and use tax registration requirements for that jurisdiction and that you are authorized to collect and remit tax as required by law.
- (3) Vendor fee. Tent rental is an additional charge of \$300.00. All fees must accompany this agreement.
